On February 1, 2021, the Ministry of the Environment, Japan is pleased to announce that 3 projects were selected in the fifth selection of the proposals for the Financing Programme for the Joint Crediting Mechanism (JCM) Model Projects in FY2020. The greenhouse gas (GHG) emission reductions through the JCM model projects are expected to accumulate to around 17.9million tons by 2030.

This time, MOEJ has selected three projects to introduce renewable energy such as mini hydro power and solar power generation. MOEJ continues to contribute to the realization of a decarbonized society by promoting the JCM.
