Micro Grid Energy Management System and 1MW Lithium ion battery are combined with 1.6 MW of solar power plant in Addu Atoll, the second biggest island in Maldives. This combination enables optimal control of the system based on weather forecast and PV output fluctuation. This project also contributes to the renewable energy target of Maldives’ energy policy and strategy in align with Goal 7 of the SDG.
