On February 8, the Joint Committee of the Joint Crediting Mechanism (JCM) between Mongolia and Japan decided to notify each side of the quantities of credits to be issued for the project below. The project is supported by the Financing Programme for JCM Model Projects by the Ministry of the Environment, Japan (MOEJ). Based on the contribution to the project, the Government of Japan (GoJ) will acquire 21,251 tons of credits.
