[1] The Third Global Conference on Strengthening Synergies between the Paris Agreement and the SDGs (MOEJ)

The Third Global Conference on Strengthening Synergies between the Paris Agreement on Climate Change and the 2030 Agenda for Sustainable Development, co-organized by the United Nations Department of Economic and Social Affairs (UNDESA) and the United Nations Framework Convention on Climate Change (UNFCCC) Secretariat, will be held on Wednesday 20 and Thursday 21 July 2022. The conference will be hosted by the Ministry of

the Environment (MOE), Japan, and held in a hybrid format, including online and at the United Nations University in Tokyo.

The conference is planned to hold discussions based on the advanced efforts of countries and relevant stakeholders to build a basis for synergistic action in support of the achievement of the various goals of the SDGs, and to raise ambition to achieve the Paris Agreement's goals and promote their implementation. Details of the meeting and registration will be announced at a later date.
