[1] MOE Japan Selects Four JCM Model Projects of Joint Crediting Mechanism (JCM) Financing Support Programme for FY2022 (Second Round) (MOEJ) On August 9, 2022, the Ministry of the Environment (MOE), Japan, announced the selection of four new JCM Model Projects of Joint Crediting Mechanism (JCM) Financing Support Programme for FY2022 (second round) in addition to the 16 projects in the first round (July 1, 2022). The number of selected JCM Model Projects has reached 207 so far, and the cumulative reduction of greenhouse gas (GHG) emissions by FY2030 is expected to be approximately 19 million tons.

MOE Japan has received a variety of JCM Model Projects applications for this second round and has selected four projects related to renewable energy, such as solar and biomass. MOE Japan will continue to strongly promote the overseas expansion of decarbonizing infrastructure through the JCM, based on the "Plan for Global Warming Countermeasures (Cabinet decision in October 2021)," etc. The application period for JCM Model Projects selection in FY2022 is open until November 30, 2022.
