[1] MOE Japan Selects Five New Projects for JCM Model Projects of Joint Crediting Mechanism (JCM) Financing Support Programme for FY2022 (Third Round) (MOEJ)

On September 29, 2022, the Ministry of the Environment (MOE), Japan, announced five new projects selected for the JCM Model Projects of the Joint Crediting Mechanism (JCM) Financing Support Programme for FY2022 (third round) in addition to the 16 projects selected in the first round (July 1, 2022) and the four projects selected in the second round (August 9, 2022). The total number of selected JCM Model Projects has reached 211, and the cumulative reduction of greenhouse gas (GHG) emissions by FY2030 is expected to be approximately 19 million tons-CO2.

MOE Japan received a variety of applications for the JCM Model Projects for this third round, and selected five projects related to solar power, one of renewable energies. MOE Japan will continue to strongly promote the overseas expansion of decarbonizing infrastructure through the JCM, based on the "Plan for Global Warming Countermeasures (Cabinet decision in October 2021)" and others.

The fourth round of applications for the JCM Model Projects in FY2022 will be open until October 7, and the last applications in FY2022 will be accepted until November 30, 2022.
