[1] MOE Japan Selects Four New Projects for JCM Model Projects of Joint Crediting Mechanism (JCM) Financing Support Programme for FY2022 (Fourth Round) (MOEJ)

On December 2, 2022, the Ministry of the Environment (MOE), Japan, announced four new projects selected for the JCM Model Projects of the Joint Crediting Mechanism (JCM) Financing Support Programme for FY2022 (fourth round) in addition to the 16 projects selected in the first round (July 1, 2022), the four projects selected in the second round (August 9, 2022) and the five projects selected in the third round (September 29, 2022). The total number of selected JCM Model Projects has reached 215, and the cumulative reduction of greenhouse gas (GHG) emissions by FY2030 is expected to be approximately 20 million tons-CO<sub>2</sub>.
