There were a number of participants from both the governments and the private sector, and the participants had active discussions on possible projects, technical support, and so on.

[2] MOE Japan Selects Five New JCM Model Projects of Joint Crediting Mechanism (JCM) Financing Support Programme for FY2023 (Third Round) (MOEJ)

On February 2, 2024, Ministry of the Environment (MOE), Japan, announced five new projects selected for the JCM Model Projects of the Joint Crediting Mechanism (JCM) Financing Support Programme for FY2023 (third round) in addition to the four projects in the first round (August 17, 2023) and the four projects in the second round (October 5, 2023). The total number of supported JCM Model Projects has reached 240, and the cumulative

reduction of greenhouse gas (GHG) emissions by FY2030 is expected to be approximately 20 million tons-CO2.
